GENERAL INFORMATION

MUTINY™ 3 PEAT is specifically formulated for foliar delivery of manganese, zinc and boron for all crops.

RATE RECOMMENDATIONS

Foliar Application

Ground: Apply 1-2 quarts in a minimum of 10 gallons of water per acre and repeat as needed.

Aerial: Apply 1-2 pints in a minimum of 5 gallons of water per acre and repeat as needed.

Soil Application

Use 1-3 quarts per acre. Not for use with starter fertilizer.

Optimum rate of application will vary depending on treatment interval, soil properties (such as pH, organic matter content, texture), weather conditions, time of year, plant species and its nutrient requirements. For best results, follow soil/tissue test recommendation.

MIXING AND HANDLING INSTRUCTIONS

Fill mix tank with half of required water volume and begin agitation. Add products in this order, mixing thoroughly after each addition: adjuvants, pesticides, then fertilizers. Fill tank with remainder of water and continue agitation until solution is completely mixed. Check chemical mixture compatibility using a jar test prior to application, especially for high phosphate and alkaline (high pH) solutions.

For full strength application, handling or storage equipment MUST consist of either PVCs, polypropylenes, most plastics, or stainless steel. Never use mild steel, nylon, brass, aluminum or copper around, to store, or to handle full strength MUTINY™ 3 PEAT. Rinse handling equipment after use if material is susceptible to corrosion.
