GENERAL INFORMATION

Mutiny™ COC is for use with any number of pesticides that call for the use of a crop oil concentrate on the product label.

DIRECTIONS FOR USE

The addition of adjuvants to some pesticides and/or fertilizers and their tank mixes may cause phytotoxicity to the foliage and/or fruit of desirable crops. The applicator or crops advisor must have experience with the pesticide combination, including Mutiny™ COC, or must have conducted a phytotoxicity test prior to use.

SHAKE WELL BEFORE USING.

FOR USE WITH HERBICIDES REGISTERED FOR AGRICULTURAL, FORESTRY, INDUSTRIAL, MUNICIPAL, NON-CROPLAND, RIGHTS-OF-WAY. NOT FOR AQUATIC USE.

USE RATES

Use 1-2 pints per acre for ground applications¹ and 1-2% v/v in 1-5 gallons of water per acre for aerial applications².

¹Use the higher rate when weeds are under environmental stress, at the maximum labeled size for control or apply 1.0% v/v (1 gallon of VIGOR per 100 gallons of spray solution) per pesticide label recommendations. ²Use higher concentrations for lower water volumes.

MIXING

In the absence of specific mixing instructions found on the pesticide label, fill the spray tank with at least 50% of the desired finished carrier volume. When premixing in a mixing vessel or inductor, fill with at least 20% of the desired finished carrier volume. While the carrier is agitating, add tank mix ingredients in the following order:

- Compatibility agent and/or antifoam, if needed
- AMS, dry formulations (WP, DF, WDG, SP), and drydrift retardants
- Dry soluble and suspension fertilizers / micronutrients
- Liquid drift retardants and flowable formulations (F & FL)

- Liquid concentrates, suspension concentrates, microencapsulated and capsule suspension (LC, SC, ME, CS)
- Emulsifiable concentrates (E, EL or EC)
- Solutions and soluble liquids (S or SL)
- Liquid micronutrients and fertilizers
- Water conditioners and other adjuvants (COC, HSOC, MSO, NIS)
- Finish filling

STORAGE AND DISPOSAL

Protect product from freezing. *If product freezes, warm to room temperature and agitate before use.* Keep containers sealed when not in use. Store in original container only. Do not reuse empty container. **CONTAINER DISPOSAL:** Triple rinse (or equivalent) during mixing and loading. Recycling decontaminated containers is the best option of container disposal. The Agricultural Container Recycling Council (ACRC) operates the national recycling program. To contact your state and local ACRC recycler visit the ACRC web page at www.acrcycle.org. Decontaminated containers and materials must be disposed of in a manner allowed by local, state and federal laws and regulations.
