DIRECTIONS FOR USE

GENERAL INFORMATION: Irruption™ DD is a drift reduction and spray solution deposition aid that will increase canopy penetration and leaf surface coverage while simultaneously reducing driftable fines. The addition of adjuvants to some pesticides, and fertilizer mixes may cause phytotoxicity to desirable crops. Before using Irruption™ DD, the applicator or crops advisor must have experience with the pesticide combination, with Irruption™ DD, or must have conducted a phytotoxicity test.

USE RATES

For use with herbicides, insecticides and fungicides.

- 4-6 oz. per acre in 5-20 GPA applications.
- 6-8 oz. per acre in 20-40 GPA applications.
- 8-10 oz. per acre in 40-60 GPA applications.

MIXING

In the absence of specific mixing instructions found on the pesticide label, fill the spray tank with at least 50% of the desired finished carrier volume. When premixing in a mixing vessel or inductor, fill with at least 20% of the desired finished carrier volume. While the carrier is agitating, add tank mix ingredients in the following order:

- Compatibility agent and/or antifoam, if needed
- AMS, dry formulations (WP, DF, WDG, SP), and dry drift retardants
- Dry soluble and suspension fertilizers / micronutrients
- Liquid drift retardants and flowable formulations (F & FL)
- Liquid concentrates, suspension concentrates, microencapsulated and capsule suspension (LC, SC, ME, CS)

- Emulsifiable concentrates (E, EL or EC)
- Solutions and soluble liquids (S or SL)
- Liquid micronutrients and fertilizers
- Water conditioners and other adjuvants (COC, HSOC, MSO, NIS)
- Finish filling to desired spray volume level and continue agitation

STORAGE AND DISPOSAL

This product does not require heated storage. Keep containers sealed when not in use. Store in original container only. Do not reuse empty container. Triple rinse (or equivalent) during mixing and loading. Recycling decontaminated containers is the best option of container disposal.
