RATE RECOMMENDATIONS

FOLIAR APPLICATION

Ground: Apply 1 to 4 quarts in a minimum of 10 gallons of water per acre and repeat as needed.

Aerial: Apply 1 to 3 quarts of water per acre and repeat as needed. For rates 2 quarts per acre and above its recommended to apply with 5 gallons of water per acre.

SOIL APPLICATION

Use 1 to 8 quarts per acre. Do not use or mix with starter fertilizer.

Optimum rate of application will vary depending on treatment interval, soil properties (such as pH, organic matter content, texture), weather conditions, time of year, plant species and its nutrient requirements. For best results, follow soil/tissue test recommendation.

MIXING AND HANDLING INSTRUCTIONS

Fill with 1/5 to 2/5 of total required water volume in tank. Add adjuvants, fertilizers, and pesticides if desired and agitate until thoroughly mixed. Add recommended amount of this product and agitate until thoroughly mixed. Fill tank with remainder of desired water. Check chemical mixture compatibility using a jar test prior to application.

When tank mixing with crop protectants in low water applications, such as aerial applications, be sure to have enough water to allow for proper dispersion of crop protectants.

ATTENTION: This product contains boron; use on any crops other than those recommended may result in serious injury to the crops. The application of fertilizing materials containing molybdenum (Mo) may result in forage crops containing levels of molybdenum (Mo) which are toxic to ruminant animals.
